"From the Chapter President"

It is an honor for me to be elected chapter president for the next two years. I am excited about the opportunity and feel very prepared for the job after watching the Master, Charlie Finnigan, over the past five years. Charlie did a fantastic job in leading our chapter and we all owe him a debt of thanks!

I also want to thank all of the chapter board officers and directors for volunteering their time and energy. All of us realize how important they are to the success of our chapter.

Looking ahead, I have decided to focus on a few areas for 2023 and beyond. The basis for these areas of focus is achieving a 5 star Level of Excellence (LOE) award for the chapter. This award is given by the national headquarters to those chapters that meet certain goals. Fortunately, due to Charlie's leadership, we already meet most of them. There are a few that are constantly needing attention, however, and that is what I'm going to address.

First of all, I want to grow our membership. We are a very healthy chapter - we have 86 members, which is about average for the chapters in Florida. However, if we don't constantly look for new members, we will decline. To that end, the board has agreed with some proposals to encourage new members to join:

- -Any existing member who brings in a new member (who signs up and pays dues) will get one free year of chapter membership (\$25 value).
- -To provide opportunity for participation to those MOAA members (and potential members) who work during the day and can't attend our Tuesday luncheons, we will have periodic no-host socials in the evening at local establishments. The first is scheduled at Mocama at 1730 on 8 Feb.
- -Along the same lines, we will have one general meeting per quarter in the evening the same format will be followed, including a meal and speaker.

Secondly, we will be applying for a MOAA grant. This is an annual grant that the national MOAA organization provides to worthy causes at the chapter level, up to \$5000. We will be applying for a grant to help renovate and expand the Veterans Memorial Park where we hold our brick-laying ceremony on Memorial Day.

Also, we will be creating a higher profile for our chapter in the local area, through more articles in local papers as well as participation in events. Anyone who has ideas for "growing our brand" in the community, please let me know. If attending the monthly meeting is all you are interested in, this won't affect you - just keep doing what you are comfortable with.

The bottom line is that we will continue to do the things that all of us enjoy - meet for lunch and the camaraderie of our friends during our monthly chapter meetings. But we will also be expanding our scope of activities to be more accommodating to those with day jobs as well as raise the awareness of our chapter in the community.


